- 1) Investment interest (cash receipts) for FY 1992 through FY 2006 totals \$946,194,354.48. OSM transferred \$804,405,397.79 to the United Mine Workers of America Combined Benefit Fund in the years 1995 - 2006, inclusive. Net investment interest after the transfers is \$141,788,956.69. Congress also authorized OSM to transfer \$7,000,000 in investment earnings to fund Appalachian Clean Streams Initiatives in FY 1999. This came from interest earned in FY 1992.
- 2) Public Law 109-54 provided that the balance of the RAMP pool (section 402(g)(2) of the Surface Mining Control and Reclamation Act of 1977) on September 30, 2005, is reallocated to the allocation established in section 402(g)(3) (Federal Expense Allocation) of the Surface Mining Control and Reclamation Act of 1977.
- 3) Does not include \$1,178,271.71 in reimbursable activity in FY 1992 and FY 1993.
